### *Family Mediation*

Separation does not need to become a war, nor do children have to be the battleground.

A separated couple will still have to work together as parents.

They may even have to leave their homes, their schools, their friends. It can be no surprise that children whose parents are separating may become ill, withdrawn, and have problems at school.
